Co-authored National Service: Social, Economic, and Military Impacts (1982) and The Moral Equivalent of War? A Study of Non-Military Service in Nine Nations (1990). Wrote reports, developed research and policy network, organized national and international conferences, gave presentations and congressional testimony, and assisted in writing legislation. Invited to the White House for signing of the National and Community Service Act of 1993 which created AmeriCorps. Consultant to the director of AmeriCorps National Civilian Community Corps in 1994. Organized and helped to design a "national project" on Individual Development Accounts for AmeriCorps VISTA, 1995–1996; this project was doubled in size in 1998 and increased again in 2000. Active in international network of national youth service. Consultant to Ford Foundation in 1998–2000 to consider global vision and next steps in national and community service; helped plan and carry out international conference in Costa Rica, January 2000. In 2000-01, designing global youth service research and information network. Beginning in 2001, founded the Global Service Institute (GSI), an international, long-term project to build a knowledge base and information network on service. Professor Amanda Moore McBride and Lissa Johnson at CSD organized and implemented GSI. Professor Margaret Sherraden has been an invaluable partner, leading a study of international service teams in North America. With GSI colleagues, organized and sponsored the first global research meeting on civic service, held in Buenos Aires, September 2002; the papers from this meeting appeared in a special issue of Nonprofit and Voluntary Sector Quarterly. Organized second international research meeting in St. Louis, September 2003; third meeting in Accra, Ghana, August 2004; fourth meeting in London, May 2005; and fifth meeting in St. Louis, March 2007. With Professor Amanda Moore McBride, published Civic Service Worldwide: Concepts and Controversies (2007). In 2000s, CSD supported several international meetings and publications in international voluntary service, and with Brookings Institution CSD cosponsored major meetings on International Voluntary Service in St. Louis, 2010; Chicago, 2013; and Durham, NC, 2015. CSD co-sponsored United Nations meeting on international service in Bonn, Germany, 2015. CSD remains engaged in domestic and international service as an expression of social commitment, and an alternative pathway toward adulthood as labor markets continue to pull away from youth.

**Productive Aging**. Organized and hosted academic meeting on productive aging at Washington University in 1998, with papers published in *Productive Aging: Concepts and Controversies* (2001). CSD housed major long-term experiment with Experience Corps in 2000s, finding positive outcomes in child reading scores. CSD initiated, coorganized, and co-sponsored first academic meeting on Productive Aging in China in 2009 at Shandong University, and second conference in 2011 at Peking University. Both conferences resulted in book and/or special journal issues in both English and Chinese, and widespread international policy discussion. Prof. Nancy Morrow-Howell at CSD led this work in Productive Aging. With aging global populations, this work continues at the Center for Aging at the WU Institute for Public Health.

**Youth Development.** Researched and wrote *Community-Based Youth Services in International Perspective* (1992) for the Carnegie Council on Adolescent Development. This report was printed with the backing of 17 sponsoring organizations and widely distributed to youth-serving organizations. It contributed to the Council's influential study, *A Matter of Time*, which helped define "positive youth development" as an alternative to problemoriented youth policy in the United States. CSD renews and applies this body of work as opportunities arise.

Welfare Reform. From 1991, helped write federal legislation to raise welfare asset limits. Advised Bush White House in its budget proposal to increase welfare asset limits to \$10,000. Worked with the Clinton White House Working Group on Welfare Reform during 1993–94, particularly regarding increases in asset limits and creating Individual Development Accounts IDAs. In 1994 IDAs were proposed by President Clinton as part of his welfare reform plan. From 1993 to 1998, served on Missouri Governor Carnahan's Welfare Reform Coordinating Committee, which designed, helped to enact, and worked on implementation of Missouri's welfare reform, based on individual contracts. Advised on asset building strategies to accompany welfare reform in Missouri, and advised in more than 20 other states. In 1996, IDAs were included as a state option for using block grant funds in the federal "welfare reform" law, establishing asset building for the poor in federal law. By 2001, nearly all states had raised asset limits in welfare transfers, and over 30 states had included IDAs in their welfare reform plans. The changes in asset limits are a major impact of the assets policy discussion, though little discussed.

Voter Access and Engagement. With the 2016 U.S. presidential election, the CSD team decided that we should turn our attention to informing the electoral process and democracy in general. We created a new initiative call Voter Access and Engagement, led by Dr. Gena Gunn McClendon. Our major research project so far has been systematic documentation of barriers to voting (insufficient staffing, long-lines, broken voting machinery) in low-income and predominantly Black neighborhoods in St. Louis. This paper, published in a major journal, identified these barriers as a systematic form of voter suppression, taking its place among many others. CSD has used the findings to inform improvements in voting process by electoral boards in both St. Louis City and County.

Asset Building for the Poor in United States. In 1988 I articulated the idea of asset-based development policy, including raising welfare asset limits and creating Individual Development Accounts (IDAs), matched savings for the poor. Published Assets and the Poor: A New American Welfare Policy (1991), defining this new approach. Undertook policy studies, reports, presentations, legislative writing, and testimony. Helped design IDA demonstrations. Advised the Bush (senior) and Clinton White House, several committees in the House and Senate, the Congressional Black Caucus, and the Congressional Hunger Caucus. Spoke at several meetings in the Bush White House; influenced President Bush's proposal to raise AFDC assets limits to \$10,000. From 1991-present, helped write federal legislation to raise welfare asset limits and create IDA demonstrations. Drafted Missouri legislation for IDAs. which is being used as a legislative model in other states. At November 2002, over 40 states and Puerto Rico had some type of IDA policy. Several other IDA or similar programs had been initiated by federal agencies, including HUD and the Federal Home Loan Bank Board. Co-organizer of First National Conference on IDAs, Chicago, November 1995; and IDA national and international conferences in 1998, 1999, 2000, 2001, 2002, and 2004. Organized and hosted national conferences on state IDA policy in 2001, 2002, 2003, 2005, 2006, and 2007. From 1997, evaluated the "American Dream Demonstration," a multi-site IDA demonstration funded by a consortium of ten private foundations (possibly the largest policy demonstration in the country at this time, outside of "welfare reform"). Initiated development, sale, and support of the Management Information System for Individual Development Accounts (MIS IDA), which from 1997 has been used to manage most operating IDA programs. In October 1998 the "Assets for Independence Act" (AFIA) was signed, creating \$125 million in federal funding for IDAs. Drafted the evaluation language for this act, and during 1999–2000 worked with Department of Health and Human Services and Abt Associates on design of the AFIA evaluation. During 1999, in partnership with the Corporation for Enterprise Development (CFED), advised the Secretary of the Treasury on other asset building anti-poverty initiatives; one of these, a federal campaign for "First Accounts," was adopted in January 2000. Expanded legislation for IDAs, the

"Savings for Working Families Act" (SWFA), introduced in the Congress from 2001 through 2008, with support in both parties and the White House. CSD has continued to advise consult with many state and local IDA projects and research in 2000s and beyond. From 2010 to 2015, CSD has played a convening role in the Southern Regional Asset Building Coalition (SRABC), a grassroots initiative to with Historical Black Colleges and universities, community development organizations, and state governments to build political support and capacity for asset building strategies in the South. Dr. Gena Gunn McClendon led the SRABC work, which continues in the Alabama Asset Building Coalition and other organizations. CSD continues to consult with many state and local asset building organizations and initiatives. The diversity of asset building applications is now challenging to track. The concept and language of inclusive "asset building" has moved from a totally new idea to mainstream discussion in social policy.

Large-scale, Inclusive Asset-Based Policy in the United States. Universal and progressive asset accounts proposed in 1991 in Assets and the Poor. In 1996, proposed a system of Universal Savings Accounts (USAs) for the United States to be used by the entire population for a broad range of policy purposes (retirement security, home ownership, education and training, small business development, and possibly medical care). In 1996 wrote "Social Security in the 21st Century," which outlines the context of the current addition of asset accounts and emphasizes inclusion of the whole population. From 1996, in partnership with CFED, working with a research and policy team to create USAs as a major domestic policy strategy in the United States. With Bob Friedman at CFED, I was co-founder and co-chair of the Growing Wealth Working Group, a group of academics and policy analysts examining asset-based social policy options. Consulted with Clinton White House and the Department of Treasury on systems of asset accounts. In January 1999, USAs proposed by President Clinton in State of the Union address, with matched savings for the poor. In 1999 provided IDA research data and policy consultation leading to President Clinton's January 2000 proposal for multi-purpose, progressively-funded Retirement Savings Accounts (RSAs); in his State of the Union address the President pointed to the influence of IDAs (based on CSD research data) in making this proposal. Organized and hosted an academic meeting on "Inclusion in Asset Building: Research and Policy Symposium" at Washington University in September 2000. In 2000 and 2001, matched savings included in bipartisan Congressional proposals for individual accounts in Social Security. In October 2001, testified before President Bush's Commission to Strengthen Social Security, advocating inclusion and progressivity in individual accounts above and beyond social insurance (i.e., an "add on" account). CSD data on IDAs quoted in the Final Report of the Commission, with progressivity included in some of the policy options, and in the 2002 Economic Report of the President. In 2005 testified on Inclusion in Asset Building before the Subcommittee on Social Security and Family Policy, Finance Committee, US Senate. During 2008 Presidential election campaigns, forms of progressive savings policy offered by leading candidates, and this has continued. Asset-building is a generative concept, with a wide variety of innovations aiming for inclusive asset-based policy.

Universal and progressive Child Development Accounts. In Assets and the Poor (1991), IDAs were proposed as universal, progressive accounts beginning at birth. This may have been the first written proposal for an inclusive (universal and progressive) children's savings account. In 1991, at the request of HUD Secretary Jack Kemp and the Bush White House, I developed a proposal for all children in America to begin life with an account. In 2000, with CFED, co-hosted a meeting of experts in Washington on universal Children's Savings Accounts, Between 2000 and 2004 worked with UK government (see below) on the Child Trust Fund, a universal, progressive children's development account (CDA). In 2003, co-authored with Ray Boshara an op-ed in New York Times on a universal CDA. From 2000, with CFED and other partners, planned for a demonstration of CDAs, and designed research for a large CDA initiative known as Saving for Education, Entrepreneurship, and Downpayment (SEED), funded by the Ford Foundation and other foundations. In 2007–2008, several bills were initiated with bipartisan support in Congress to create large-scale CDAs in the United States. From 2004 through 2016, implemented SEED demonstration and research, including a rigorous experiment in Oklahoma called SEED for Oklahoma Kids (SEED OK), which was launched with Governor Brad Henry in June 2008. The policy design for SEED OK is from Margaret Clancy at CSD, and it has proven to be well-conceived. CSD works with many states to create more inclusive and progressive features in College Savings Plans, with an ultimate goal of an automatic and progressive savings account for every child at birth. Maine, Nevada, and Rhode Island announced this CDA policy during 2014. Since that time, Connecticut, Pennsylvania, Nebraska, Illinois, and California have enacted universal CDAs. All of the statewide CDA policy innovations use the policy model tested in SEED OK and CSD has advised in all these states. CSD continues to consult in other U.S. states and at the federal level. City level CDA programs have emerged in San Francisco, St. Louis, Oakland, Lansing, New York City, and elsewhere. In recent years, variations on this concept, including Baby Bonds, have enriched the policy discussion. Prof. Trina Shanks and Prof. William Elliott contribute a great deal to research and policy design. As of 2023, over five million children in the U.S. have a child development account, and

over 15 million worldwide (see below). The long-term vision at CSD is that someday all children on the planet can start life with a CDA.

Financial Capability and Asset Building (FCAB). Expanding the above work to include Financial Capability, CSD has been designing and testing strategies to deliver professional financial guidance to the full population (not just to the wealthy). This body of work is called FCAB and centers on using practicing social workers and other human service professionals to include basic finance in their skill set. Prof. Jin Huang, Prof. Margaret Sherraden, Lissa Johnson, and Dr. Gena Gunn McClendon at CSD have provided FCAB leadership. The reasoning is that most low-income people with social problems also have financial challenges, often extreme, and social workers are the profession in the field and most in touch with these populations. As Jane Addams said, social workers are "among the people" and these relationships are a strong foundation upon which to improve financial capability and asset building. Led by CSD, FCAB became one of the Grand Challenges for Social Work in 2016, and continues to build evidence and impacts on FCAB training for social workers. CSD has produced the first FCAB textbook, and sponsored or co-sponsored numerous FCAB conferences, special sessions, and other meetings.

**Asset-Based Policy in other Countries.** The concepts of inclusive asset building, Individual Development Accounts and Child Development Accounts, along with CSD's research and publications on these topics, have influenced discussions, proposals, and policy developments in other countries:

Australia: In the early 2000s I consulted with members of the Labor Party and private banks regarding matched saving strategies. The Labor Party, particularly Member of Parliament Mark Latham, have proposed several schemes for inclusive asset-based policy, including Lifelong Learning Accounts and Nest-Egg Accounts (in 2003 Latham became head of the Labor Party). In 2002, ANZ Bank and Brotherhood of St. Laurence initiated a matched saving pilot project for Community Partnership Savings Accounts "based on an American model of individual development accounts" and citing CSD research data. In 2005, gave a series of invited presentations and consulted with ANZ and Victoria state government officials on matched savings and asset building; Victoria government moving forward with funding.

*Azerbaijan:* Policy consultations on CDAs have been underway with senior government officials from 2015 to the present. CSD is co-sponsoring an FCAB conference in Baku in November 2023. Dr. Aytakin Huseynli at CSD leads these initiatives.

Canada: From 1998, consulted with Canadian government and non-profit organizations running IDA programs. Several IDA programs started in Canada, and a large IDA demonstration, Learn\$ave, initiated in 2001. Consulted with Social Demonstration Research Corporation on research design for Learn\$ave. Home\$save, a matched savings program for home ownership, began a demonstration in 2004. Canada has since moved forward with plans to provide incentives for low-income families to take advantage of Registered Education Savings Plans, with deposits of \$500 at birth and \$100 per year through age 15, and other educational savings incentives.

China, Mainland: In November 2002, asset building and CSD's research on IDAs mentioned in the 16th Communist Party Congress in Beijing, with favorable commentary. In Fall 2004, CSD co-organized and co-sponsored a conference on asset-based policy with Shandong University, with conference papers published as a book in 2005. In January 2005, the Chinese Academy of Social Science and Tsinghua University held conferences in Beijing (I was keynote speaker at both meetings) to discuss asset-based policy options and begin planning demonstration and research IDA projects. The Taiwan experience (see below) is of great interest to Chinese scholars and policy makers. In Fall 2005, invited to speak on asset building at 21st Century Forum in Beijing, and consulted on project site in Xin-Jiang region regarding an asset building innovation within the Rural Retirement Insurance scheme. In September 2005, Assets and the Poor published in Chinese and received Honorary Professorship from Shandong University, with growing discussion of asset-based theory and policy in China. In 2012, led conference on Lifelong Asset Building at Peking University in Beijing, with book publications in both Chinese (Peking University Press) and English (Taylor and Francis). Also in 2012, gave keynote address at conference in Beijing on asset building as social innovation for migrant youth (see Child Development Fund in Hong Kong below). Since 2019, FCAB has sprouted and expanding in mainland China. The CSD textbook is being translated into Chinese, and the Universities of Finance and Economics are beginning new social work training programs on Financial Social Work. A Financial Social Work Commission has been formed at the national level. Prof. Jin Huang leads FCAB work in China, and Li Zou has supported all of this policy development from the beginning.

Hong Kong: In 2000 met with Hong Kong Council of Social Welfare and introduced asset building policy. In November 2006 keynote speaker in Hong Kong at a conference on Child Development Accounts (CDAs). In March 2007, Hong Kong government announced creation of a Child Development Fund that includes CDAs, though by end of 2007 this had become a demonstration project for about 700 youth. From 2008, research consultant on the Child Development Fund. In 2012, Child Development Fund expanded.

Indonesia: Co-sponsored conference in 2004 on social development, with emphasis on asset-building. In 2005, advised on including asset-building in social policy reform. Continuing to work with University of Indonesia and Ministry of Social Welfare. In 2005, government proposals and plans for IDA pilot projects. CSD asked to help design the pilots and assist with research. In 2006, Assets and the Poor published in Bahasa Indonesian, keynote speaker at major conference on asset building, meetings with Minister of Social Welfare, continued planning of asset building pilot projects. In December 2008, Indonesia adopted a new social policy based on the theme of social investment, with asset building schemes included in this policy strategy.

*Israel:* Advised and policy proposals beginning in 2004. Prof. Vered Slonim Nevo was highly involved in early policy development, and Prof. Michal Grinstein-Weiss later contributed. In January 2017 Child Development Accounts were enacted and opened for all citizen children under 18 years of age, and some non-citizen Palestinian children in East Jerusalem. Accounts have initial deposit and regular monthly deposits from government equivalent to about US\$17.

Kazakhstan. The President of Kazakhstan announced that all newborns would receive an automatic CDA starting in January 2024, and that one-half of the country's oil revenues would fund these accounts. The research of Dr. Aytakin Huseynli at CSD spurred this policy development in Kazakhstan. This will be the first application of CDAs in a country that suffers from the "resource curse" (meaning that natural resources actually make the population worse off). As such, it could become a model for other resource curse nations.

*Korea:* Responded to numerous inquiries. Government proposal in 2005 to begin an IDA demonstration program; and another government proposal in 2006 to begin a Child Development Account (CDA) program. Keynote speaker on CDAs to Ministry of Health and Social Welfare, November 2006, and in 2007 Korean government began CDAs with institutionalized children, to be expanded to approximately half of all Korean children over time. In 2008 the Seoul Welfare Foundation began a pilot of IDAs. In 2010, Seoul's "Hope Development Accounts" won a public service award from the United Nations. IDAs continue to expand to other cities in Korea over time. In 2020 gave keynote speech at anniversary conference of asset building policy in Korea.

*Mexico*: In 1993, consulted with the government of Mexico on shifting a portion of social security retirement policy to asset accounts, and making the system inclusive. In 1996, lead speaker at a research and policy conference in Mexico City on social security, again discussing inclusive asset building accounts. Dr. Clemente Ruiz Duran continues to be an invaluable partner.

Puerto Rico: In 2007, advised Mayor Miranda Marin of City of Caguas, Puerto Rico, on plan to create Child Development Accounts (CDAs) for all newborns in the city as a community development strategy—the first citywide application of children's accounts, to begin in 2008. In 2008, government decided to make all Puerto Rican TANF participants eligible for IDAs. Consulted in both of these initiatives.

Singapore: From 1991 to the present, have undertaken a major study of Singapore's Central Provident Fund, a domestic policy system based on asset accounts, and advised government officials. Dr. Sudha Nair has been an invaluable partner. In 2001 Singapore announced a policy of Child Development Accounts (CDAs). In 2004, CDAs expanded to every child through the fourth birth in a family, with government deposits to be used for child care and early educational expenses. In 2010 co-hosted with Center for Social Development Asia at National University of Singapore a conference on Singaporean social policy, with major emphasis on comprehensive asset building. In 2016 Singapore announced a CDA expansion of S\$3,000 for each newborn. CDA and other child and youth asset-building policies have continued to expand, so that Singapore now has the strongest asset building policies that include all children. In addition, working with CSD, Singapore has translated the FCAB textbook into the Singapore context and is training social workers in FCAB. Margaret Sherraden led this successful FCAB transfer to Singapore.

Taiwan: Beginning in 1998 advised the city government of Taipei on IDAs as an anti-poverty strategy, and consulted on design of Family Development Accounts (FDAs) introduced in Taipei in 2000. Taipei FDA research project is led by Prof Li-Chen Cheng. In 2004, this project was slated for expansion to youth development accounts. National legislation for FDAs introduced in 2008. FDAs continue to expand to other cities in Taiwan. In 2016, the newly elected President in Taiwan has identified CDAs as a top policy priority, following the model in Korea of serving disadvantaged children. In 2018 met with Taiwan Vice-President and other senior officials that the Presidential Office Building to discuss universal and automatic opening of CDAs at birth. The FCAB textbook is also being translated into Chinese in Taiwan.

*Uganda:* From 2003, supporting matched saving initiative and research connected with a microenterprise program of International Care and Relief, Uganda, led by Gina Chowa. From 2004, supported a second matched savings program and research with HIV/AIDS orphans in Uganda, led by Prof. Fred Ssewamala. This work led to major funding in 2012 by National Institutes of Health in the US for expansion of savings for economic development and health outcomes, and this work has continued to expand.

*United Kingdom*: In June 2000, advisory session with UK Treasury officials on asset building as an antipoverty strategy, and made speeches on this topic with David Blunkett, Secretary for Employment and Education. In January 2001 co-hosted an international meeting on "Asset-Based Welfare" in London. In 2001 Prime Minister Tony Blair proposed "progressive, universal" asset-based policies, a Child Trust Fund (saving accounts for all UK children, with greater deposits for the poor), and Saving Gateway (matched savings for adults, a version of IDAs). H.M. Treasury documents in 2001 cite IDA research from CSD. In October 2001, speech on "Wealth and Welfare" with Alistair Darling, Secretary of State for Work and Pensions, at the annual meeting of the Labour Party, In 2001, advised Ruth Kelly, Economic Secretary to the Treasury, and other Treasury officials on Child Trust Fund and Saving Gateway. In September 2002 spoke at seminar at 10 Downing, sponsored by Prime Minister Tony Blair, and gave dinner speech at 11 Downing, hosted by Chancellor of the Exchequer Gordon Brown, on the proposed Child Trust Fund. In April 2003, Prime Minister Blair announced funding for a universal, progressive Child Trust Fund, an account for all newborns in the UK; officials in the Prime Minister's Office and Treasury sent congratulatory notes crediting CSD research evidence and the September 2002 meetings with influencing this policy decision. In 2004 presented a paper on Assets and Social Mobility at a seminar organized by Chancellor of the Exchequer Gordon Brown. In 2007, meetings with advisors of Prime Minister Brown at 10 Downing on future of Child Trust Fund and Saving Gateway, and potential influence of these policies abroad. Notwithstanding positive results, with election of coalition government in 2010, funding for Child Trust Fund and Savings Gateway cut in budget austerity campaign. In 2012 met with policy makers at National Employment Savings Trust in London for design of universal asset-building policy associated with employment.

**Regional and global asset-based initiatives.** In some situations, policy discussion and development is occurring across borders:

Africa: From 2001, working with African graduate students at Washington University, known as AssetsAfrica, to develop and initiate one or more asset building demonstration projects in Africa. First demonstration and research project implemented with International Care and Relief, Kampala, Uganda, led by Gina Chowa. Fred Ssewamala initiated a second project in Uganda, CDAs for HIV/AIDS orphans; this project is now expanded and supported by the National Institutes of Health. The long-term plan is to model, test, and disseminate asset building into other African nations. In 2013 consulting on expansion of child and youth account demonstrations in South Africa. In 2021, launched Financial Capability and Asset Building in Africa (FCAB Africa), led by former PhD student David Ansong, with launch event at conference of International Consortium for Social Development, hosted by Centre for Social Development in Africa (CSDA), a sister center of CSD, at University of Johannesburg, with Vice President of Ghana giving keynote speech.

Global Assets Project: In 2006 CSD joined with the New America Foundation to create the Global Assets Project (GAP). The first major initiative of GAP was a global conference in Singapore in June 2007, bringing together experts in asset building and microfinance. With the Center for Social Development Asia, CSD co-sponsored a high level conference on Singapore's Social Policies in 2010. CSD worked with Save the Children, CGAP at World Bank, and New America Foundation to test youth savings accounts in Colombia, Ghana, Kenya, and Nepal; this initiative, called YouthSave ran from 2010 through 2015.

Latin America: Edge Finance in Peru and Colombia, using IDAs as a model, has successfully initiated matched savings among thousands of poor, rural women, using commercial financial providers (aiming for scale and sustainability). In 2008, Michael Sherraden and Margaret Sherraden met with and discussed expansion of this concept with top level government officials from Argentina, Bolivia, Chile, Colombia, Ecuador, Mexico, and Peru.

Middle East: In 2004, working with Jewish and Arab colleagues, proposed a Middle East Development Account for all Israeli and Palestinian children. As a first step toward this goal, accounts for all impoverished Israelis, Jewish and Arab, are under consideration by national policy-makers. The first IDA program in Israel, which will reach both Jewish and Arab women, began in 2008. In 2008, Israeli government announced planning for Child Development Accounts with statements from top ministry officials. Discussions renewed and continued in 2013, and in 2015 universal CDAs are enacted for all Israeli children, with implementation planned in 2017. Today, the Israeli CDA policy reaches all citizen children with automatic account opening at birth, and is the only CDA policy to make regular monthly deposits.

European Commission: Met with emerging network of scholars and policy makers across Europe in 2013, and gave keynote speech at meeting on saving in social policy in Brussels. Since that time occasional consultations on CDA research and policy initiatives in other European countries. Other engagements in Europe have been sporadic, but sprouts of asset-building policy are becoming more common.

*OECD*: Consulted with delegation from OECD attending April 2002 IDA and Asset Building conference in Windsor, Ontario. In 2003, OECD publication of *Asset Building and the Escape from Poverty: A New Welfare Policy Debate* in 2003, for distribution in several languages (translated into Italian and Spanish in 2004); CSD asset-based theory and research cited extensively in this publication.

*United Nations*: In 2002, IDAs and asset building examples from CSD included in a report on Social Development Partnerships prepared for the UN Commission on Social Development. In 2015 I delivered the keynote speech at Social Work Day at the UN.

US Agency for International Development: In January 2004 presented a paper at a USAID meeting on asset-based development strategies in Washington, DC. A follow-up meeting was held in June 2004. Asset-building is now commonly used language in development.

World Economic Forum: In 2003, helped organize an international planning meeting on asset-based policy in Geneva, Switzerland.

*YouthSave countires:* YouthSave was an applied research in Kenya, Ghana, Colombia, and Nepal, led by CSD and partnering with Save the Children from 2010 to 2014. YouthSave generated key evidence and had a positive impact in opening up the youth market for mainstream banking. These impacts continue, especially in Ghana.

*Post-Soviet countries:* As noted above, CDA policy and FCAB professional practice are advancing in Azerbaijan and Kazakhstan, spurring wider meetings among post-Soviet countries over the past six years and continuing.

### **Community Development**

IDAs and CDAs in Community Development. From 1990, advised, helped with design, and provided technical assistance to dozens of IDA programs operating out of community-based organizations around the country. By 2002, the number of community IDA programs exceeded 400, with many more in the planning stages. Lissa Johnson at CSD developed the Management Information System for Individual Development Accounts (MIS IDA), software to facilitate management and evaluation of IDA programs, and used at most IDA programs in the country from 1997 forward. CSD worked with United Ways around the county on asset building and IDA programs. By 2002, the United Way of America had developed an initiative on Assets for Family Success, with 35 local United Ways reporting operational IDA programs, 22 in planning, and 57 interested. Focusing on St. Louis, CSD advised in creation of IDA program funded at \$850,000 for 1999–2001 by the United Way of Greater St. Louis, with continuing funding to present. In 2007, United Way of America announced a \$1.5 billion Financial Stability Partnership focused on increasing income, building savings, IDAs, and protecting assets. In 2008, advised President of United Way on research for this initiative. Spoke at several national and international meetings of United Way during 2008–2010. Also during this period, advised Mayor Oh See-hoon and worked with Seoul Welfare Foundation in design and implementation of IDAs in Seoul, Korea—this project won a United Nations Public Service Award in 2010. From 2012 to the present, a great deal of CDA policy innovation in many US cities, including San Francisco and St. Louis, and CDAs recommended in the Ferguson (Missouri) Report in 2015. The New York City CDA program now reaches all school children in the city (Margaret Sherraden and I are heartened that our granddaughter in Brooklyn now has a CDA).

Community Reinvestment. During 1994 to 1996, helped organize and establish the St. Louis Reinvestment Corporation (SLRC), a non-profit organization representing 75 congregations and parishes in poor neighborhoods across the entire City. Raised funds for start-up. Provided technical support for SLRC planning and reinvestment initiatives. At the beginning of 1997, helped create the Justine Petersen Housing and Reinvestment Corporation (JPHRC) in St. Louis to promote home ownership and asset building through family development accounts, and served on the board from 1997–99. In 2000, JPHRC formed Great Rivers Community Capital, St. Louis's first Community Development Financial Institution.

Graduate Training in Urban Family and Community Development. From 1996, in partnership with Prof. James Herbert Williams, led planning committee at Washington University for an innovative, multi-professional, and interuniversity graduate training program in Urban Family and Community Development, to serve personnel involved in community work, human services, education, government, and other settings in St. Louis. In 1998, the Urban Family and Community Development Program was funded for its first three years of operation by the Danforth Foundation and the State of Missouri. The first cohort of students graduated in December 1999 and the last cohort in December 2001. Over 50 students were trained; some went on to masters' degree programs; most are now working in the St. Louis community.

**Home Ownership Development Accounts at city level.** Worked with the Office of the Mayor of St. Louis in 2002–03 to plan a large demonstration of Homeownership Development Accounts in two St. Louis neighborhoods. A current research project in St. Louis's "West End" is testing the idea of supporting home ownership with a significant asset transfer.

Child Development Accounts at city level. In 2007, advised Mayor Miranda Marin of City of Caguas, Puerto Rico, on plan to create Child Development Accounts (CDAs) for all newborns in the city as a community development strategy—the first citywide application of children's accounts. CSD has advised on research design. From 2007 advised the Hong Kong government on a pilot Child Development Fund that includes savings. In 2008–09 advised the Seoul Welfare Foundation on design and implementation of CDAs in Seoul. From 2009, CSD advised the City of San Francisco on creation of a city-wide CDA, leading to the Kids to College (K2C) initiative implemented in 2012. From 2013, advising the City Treasurer of St. Louis on CDAs for all St. Louis public school children. Since that time, extensive advising in US cities and other local applications of CDAs.

### **Building Capacity for Social Innovation**

Center for Social Development at Washington University in St. Louis. Founding director of the Center for Social Development (CSD), which began in 1994. During the first decade, built CSD into a leading research and policy center in the applied social sciences, with three primary areas of inquiry and innovation: (1) asset building, (2) civic service, and (3) productive aging. CSD's work is respected for its academic quality and policy impacts. At its tenyear anniversary, CSD had a core staff of 12, more than 30 faculty associates, and more than 40 graduate research assistants. In its first decade, between 1994 and 2004, CSD organized or co-organized 21 national and international conferences, published more than 170 working papers and reports, published a dozen books or special issues of academic journals, and worked directly in research and policy in over 40 US states and more than 10 countries. Since that time, CSD development has continued to expand.

Resources for CSD have come primarily from philanthropic foundations and government agencies in the form of grants and contracts for specific research projects. Some resources have been generated by a technology product that has supported IDA programs. By 2005, annual grant and contract revenue was approximately \$2.5 million. CSD seeks enhanced stability through funding for core operations and endowment. In 2005, with matching grants totaling \$5 million from the Ford Foundation and Washington University, a CSD endowment was established, due to leadership of Dr. Melvin Oliver, leading scholar on race and wealth. With positive returns and revenues from software sales and support, the total endowment reached \$10 million in 2007. In 2021, the total endowment was about \$15 million.

Regarding product innovation, with the leadership of Lissa Johnson, in 1997 CSD created MIS IDA as a management information and database tool for IDA programs. We did this for research purposes, but MIS IDA became the chief tool for managing IDA programs across the country, and as a result by 2007 became the most licensed technology product of Washington University in St. Louis (in numbers of licenses, not in terms of revenue). MIS IDA has helped to strengthen CSD financially and also make CSD more visible. In 2008, CSD exited this software business, returning to the core focus on research and policy.

Centre for Social Development in Africa, University of Johannesburg. In 2005, with design support from CSD Prof. Leila Patel started the Centre for Social Development in Africa (CSDA) at University of Johannesburg. Dr. Patel wrote the White Paper on Social Welfare for the new government following Apartheid. CSD in Africa used CSD as a model. In 2013, CSD worked with CSD in Africa on a demonstration project on youth asset development and employability, and we have co-sponsored several events since that time.

Centre for Social Development, Asia, National University of Singapore. In 2006, a partner Centre for Social Development Asia (CSDA) was initiated at National University of Singapore, approved by Dean of Arts and Sciences, and launched in June 2007 by Tharman Shanmugaratum, then Minister of Education and now President of Singapore, CSD contributed to initial plans and funding. CSD contributed design and financial support. CSDA is engaged in studies in the Asia region and in comparative policy, working as a partner with CSD at Washington University in St. Louis. In 2010, CSDA and CSD co-sponsored a high level conference on Singaporean Social Policies, and in 2017 sponsored an international conference on Child Development Accounts.

Next Age Institute (NAI) partnership between Washington University in St. Louis (WU) and major universities in other countries, starting with National University of Singapore (NUS). Beginning in 2014, working with Li Zou at CSD, we initiated a university-wide partnership between WU and NUS, with focus on social innovation in era of rising inequality, aging populations, and global labor markets. Following a productive period of social innovation (e.g., see discussion above on FCAB in Singapore), NAI leadership began to extend this framework to include many other universities where we have productive partnerships. As of 2023 this NAI expansion continues to take shape.

Collaboration on Race, Inequality, and Social Mobility in America (CRISMA). CRISMA was the brainchild of David Patterson in the Brown School. CSD worked closely with Prof. Patterson on this vision, providing

financial and staff support. Unfortunately he passed away a few years ago, but not before nurturing and training Darrell Hudson. Prof. Hudson led the first, and highly successful, CRISMA conference in 2019. At that conference he announced the creation of a new university-wide Center on Race, Ethnicity and Equity. Prof. Hudson now leads this new center, and CSD continues to work with him. A major joint project at present is to create a Melvin Oliver Endowed Chair at Washington University. Dr. Oliver is a seminal figure in the study of race and wealth in America, and as a Vice President of Ford Foundation, was chiefly responsible for creation of CSD's endowment.

Grand Challenges for Social Work. I was fortunate to be in the inaugural class of a new Association for Social Work and Social Welfare or AASWSW (an "honorific society"), and became a member of the Board. A first major project of AASWSW has been Grand Challenges for Social Work (GCSW). I was on the committee designing the GCSW project and a member of Executive Committee when it was formed. I have been highly committed and proud of this work. I led two of the GCSW foundational papers: Social Is Fundamental and Grand Accomplishments in Social Work. There are now 13 "Grand Challenges" and CSD has played a leadership role in a number of them, especially: Financial Capability and Asset Building for All, Productive Engagement Across the Life Course, Smart Decarceration, and Reducing Extreme Economic Inequality. GCSW is focused on social innovation, and continues to adapt to national issues and opportunities. Lissa Johnson at CSD has played an important role throughout and now cochairs the GCSW Policy Committee.

#### **Short Bio**

I was born in Manhattan, Kansas, on May 28, 1948, a descendent of Kansas homesteaders in the 1870s. The free land distributed to my ancestors under the Homestead Act had been taken by coercion a few years earlier from Native Americans who were expelled to Oklahoma (facts long ago forgotten in our family). As an infant I contracted polio and was lucky to have only a small disability, which also had a benefit—I was always the slowest runner, so I learned how to keep going. I grew up mostly in Junction City, Kansas, attended public schools, and worked in the family grocery store. By daily example I learned from my parents how to work constructively with other people, and how to help out in the community. In 1966, I left Kansas for Harvard, aided by a "geographical admissions" policy recruiting students from across the country. This was in reality an affirmative action program for white Christians, not targeting people of color, and explicitly not Jews (a policy not discussed at Harvard University). Attending university during the "turbulent 1960s" not only provided a remarkable education, but also enriched my understanding of human sociality, and gave me practical skills in research, discussion, planning, organizing, and implementing.

Allow me a divergence on early life responsibilities. Beginning at an early age, I was employed part-time or full-time in many different jobs. These included grocery store operations, newspaper delivery, farm labor, milk delivery, dairy production, swimming instructor, lifeguard, household repairman, warehouse supervisor, highway construction, residential construction, prairie botany researcher, summer camp counselor and director, youth residential treatment director, and park ranger. I earned enough during college to pay for most of the tuition, room, and board. To pay for graduate school, I did both construction work and social research. It may seem odd to mention on a CV, but these early jobs were probably as valuable as my formal education. Above all I learned how to do things, solve problems, and appreciate many different kinds of people. Reflecting on this, I wonder how young people today might benefit from more adult-like responsibilities—employment, internships, civic service, or volunteering—beginning at earlier ages (on this, see the scholarly agenda below).

Turning to personal and family life, I met Margaret Sherrard in Nova Scotia in 1972. By a miracle she saw something in me and we have been together ever since. We married in Ann Arbor, Michigan, in 1978. Margaret is my partner at home and in our careers. We have worked as social researchers and educators for over 40 years. Some of our academic work overlaps, and much of it is international, including sabbatical years in Mexico City and Singapore. We are fortunate to have two very capable and loving adult children (Catherine and Samuel) and five precious grandchildren (Ellie, Lila, Chloe, Sebastian, and Zelma).

## Summary of Scholarship, Impacts, and Potential

Humans are highly social, and human development is fundamentally a social project. I have always been interested in a very practical question: *How can we better inform and implement social innovations?* Over the years, my answer has gravitated toward *creating and redesigning social institutions*. Sustainable institutions-formal organizaions--are how humans advance in every arena—production, commerce, education, arts, security, social welfare, and more. Institutions outlast us as individuals, and are probably the most distinctive and important thing that humans are able to accomplish. Institutions are our most important tool for advancement.

Turning to social development, my understanding of applied scholarship is that we should aim for testing institutional solutions, and use that knowledge for positive change. Unfortunately, most social research focuses on describing or explaining problems—difficulties, disparities, injustices, and so on—rather than on testing solutions. The former is much easier to do than the latter, and journalists love to write headlines about problems. In contrast, scholarship to design, implement, and test solutions requires systematic effort over many years. It may rely on large, long-term, scientifically-rigourous experiments, and it may include historical and comparative research. Despite all this work, the press may not think it is exciting enough to cover.

In this context, my first acadenic focus was on successful transition of youth to adulthood, and I begin to look at civic service as an underutilized pathway. This led to research on the Civilian Conservation Corps of the 1930s, and subsequent studies of civic service in other countries, which in turn contibuted to the creation of Americorps in the United States. I was fortunate to be at the White House for the signing of the AmeriCorps legislation. I continue to believe that forms of non-military service can play an important role in youth transitions to more engaged and productive adult lives, as well as make positive contributions to the world. This concept may be only getting started. Service could begin at earlier ages, organized through schools, and become an expected part of every life. Also, technological change, especially artificial intelligence, may transform market demand for human labor, and in this circumstance humans must ask: How can people contribute positively and find a place in society? In this context, we might imagine, for example, a large global service corps for protection and restoration of the environment. And with population aging, civic service might become common among older adults—a "Silver Corps" seeking greater engagement and meaning, with valuable knowledge and experience to contribute.

In 1994, I founded and still direct the Center for Social Development (CSD) at Washington University in St. Louis, which emphasizes evidence for effective, scalable, and sustainable policies. The aim of CSD is to inform large-scale positive change—ideally reaching millions of people. CSD's strategy is applied research--designing and testing innovations, and using evidence to inform policies and practices. Ideally, CSD itself will continue indefinitely as a small but sustainable institution, outlasting me and other current scholars. Indeed, training excellent younger scholars—racially diverse and international—is probably the best thing that CSD has accomplished.

My second major academic focus has been on introducing and developing the concept of universal, progressive, and lifelong asset building. I view asset building as a strategy for promoting social and economic development, addressing

historical racial harms, and reducing inequality. We have made a good start. "Asset building" and "asset-based policy" have become common terms in policy discussions. CSD's long-term experimental research has informed asset-building policies in the United States and abroad. Several countries and several U.S. states open asset-building accounts for all children, currently reaching over 20 million children and youth, and numbers grow with new birth cohorts. All of these asset-based policies have been informed by research, evidence and advising from CSD. Our long-term vision is that every newborn on the planet should start her life with a health check-up, a legal birth registration, and a Child Development Account to build assets for her future.

Positive change at a large scale is daunting, yet not impossible to imagine, design, test, and begin to put in place. Like all substantial endeavors, social innovation begins with a first step. It is always a work in progress; the job is never done. Like everyone, I want to do more, but we can squeeze only so much into a life. Fortunately, if we lay the groundwork effectively, others will be able to assess, critique, improve, and carry on.
